## ORDER

- A. As per Government Order read as second above, the Government have revised the existing Upper Monetary Limit to various categories of Sanctiong Authorities for sanctioning NRA/Conversion of TA to NRA subject to a maximum of 75% of the eligible balance at credit of the subscriber, as booked by the Accountant General. In pursuance of the above,
  - 1. All DDO's under the control of this office are authorized to sanction General Provident Fund NRA/Conversion to all employees under their control.
  - 2. In the case of DDO's, Controlling Officer/Immediate superior officer/Head of Department is authorized to sanction the same.

However, all NRA/Conversion of TA to NRA will take in effect only after getting online authorization of the Principal Accountant General in SPARK and all the bills of the GPF NRA will be generated and encashed by the DDO's thorugh SPARK only based on the online authorization issued by the Principal Accountant General.

B. The upper monetary limit for sanctioning Temporary Advance by different categories of sanctioning authorities have been revised as per G.O read as third above. In the order, Government interalia directed each head of Department for issuing appropriate order for effecting the upper monetary limit

specifying the Designation of officers I eculiar to the Department under intimation to Government and the Accountant General.

In these circumstances, celegation of financial powers issued vide proceedings read I<sup>st</sup> above is revised and the following delegation of financial powers for various officers in the I erala State Audit Department who are Heads of Offices/DDO's of Directorate and sub offices are ordered as noted against the category with immediate effect.
