## ORDER

Government, vide first paper read above, have created 180 additional posts in this department and staff strength has been refixed as per reference 2<sup>nd</sup> cited. Due to the lack of sufficient number of qualified hands, promotion to the post of Senior Grade Auditors from among the category of Auditors could not be completed. As per the Government letter cited, Government have permitted to appoint Auditors in the existing Senior Grade vacancies for the smooth functioning of the offices.
